Announced Business Closings and Permanent Layoffs

During July 2010, the following business closings and permanent layoffs were announced. These data are derived from a statewide survey of newspaper accounts of closings and layoffs, and from information supplied to the Employment Security Commission of North Carolina by the employing units experiencing the closings and layoffs. THE DATA ARE NOT COMPREHENSIVE AND DO NOT MEET THE LABOR MARKET INFORMATION DIVISION STANDARDS FOR ACCURACY. Staff in the Employment Security Commission neither analyze nor evaluate the accuracy of these reports.

*Note: For "#Affected", if blank = Unknown. The "# Affected" CANNOT BE USED FOR A COUNT for all workers experiencing layoffs in North Carolina during the stated period. "# Affected" represents only those workers experiencing layoffs AS REPORTED by the above-stated sources.
